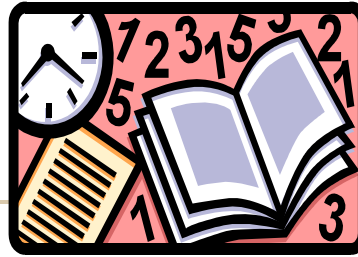


## Reduced Costs

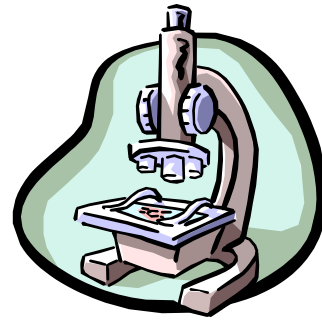
## Litigation Support
